



PERMIT TO BUY REAL ESTATE

A permit application is subject to a processing fee of 170 €/real estate unit, which shall be paid in advance of the processing. The invoice is sent to the applicant's (or to his/her representative's) e-mail, once the application has been received at the Ministry of Defence.

Even though the application can be filled in English, the decision shall be issued in the official languages; Finnish or Swedish.
